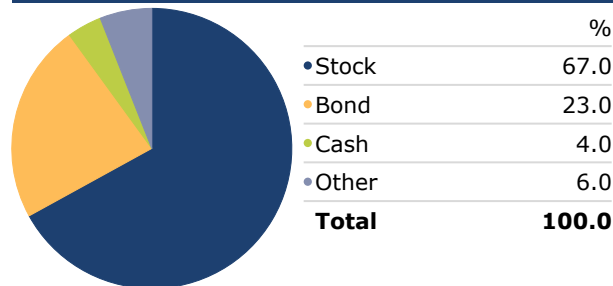


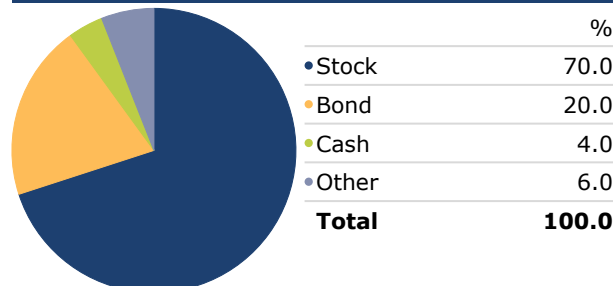

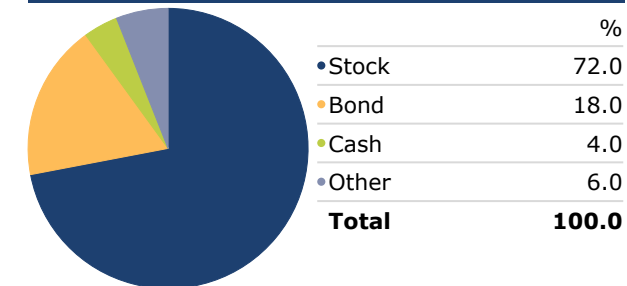
11-19 Years Conservative Strategy
